New Empirical Studies Support Director-centric Governance

Two very recently released academic papers, reporting impressive empirical work, call into question the empirical studies relied on by academics and others who campaign against staggered boards and the other means of preserving director-centric governance, and who support activist hedge fund attacks on companies and oppose anything that would limit shareholder-centric governance.
